

LIMITED WARRANTY

Subject to the terms and conditions of this Limited 25 Year Product Warranty, NEW PLASTICS CORP., through its RENEW PLASTICS division (hereinafter "Manufacturer") warrants to the original purchaser ("Purchaser") of TRIMAX® products that, for a period of (25) Years from the date of purchase from a TRIMAX distributor authorized by Manufacturer, TRIMAX products used in normal applications will not splinter, rot, decay, or suffer structural damage from termites, each a defect, under normal consumer use and conditions.

If TRIMAX products are found to be defective, Manufacturer at its exclusive election, will promptly repair or replace the defective TRIMAX products, or refund the Purchaser's purchase price. Refunds, if any, shall apply only to that portion of products actually determined to be defective, regardless of the aggregate amount to products purchased. In no event shall Manufacturer be responsible for costs and expenses incurred for inspection, labor, removal, installation, reinstallation, architect, contractor or engineering services, storage, freight or any other charge incurred by Purchaser related to defective product.

To make a claim under this Limited 25 Year Product Warranty, Manufacturer must receive from Purchaser, within the warranty period (i) written proof of purchase, (ii) a photograph of the TRIMAX products claimed to be defective, and (iii) a written description of the claimed defect(s). Purchaser must send warranty claim to the following address within 30 days after discovering the claimed defect, and prior to beginning any repair or alteration to the TRIMAX products. Manufacturer shall have 30 days following receipt of any warranty claim to conduct a preliminary investigation of, and provide a preliminary response to, a claim made under this Limited Warranty, and Purchaser shall give Manufacturer (or its agents) reasonable access to the property and/or the structures incorporating TRIMAX products for inspection purposes. MANUFACTURER'S LIMITED 25 YEAR PRODUCT WARRANTY AND THE REMEDIES SET FORTH HEREIN ARE PURCHASER'S SOLE AND EXCLUDING REMEDY, AND ARE OFFERED BY MANUFACTURER IN LIEU OF ALL OTHER WARRANTIES, GUARANTEES AND/OR REMEDIES WHATSOEVER, INCLUDING BUT NOT LIMITED TO IMPLIED WARRANTIES OF MERCHANTABILITY AND/OR FITNESS FOR A PARTICULAR PURPOSE UNDER THE UNIFORM COMMERCIAL CODE, OR OTHER WARRANTIES OR GUARANTEES ARISING BY OPERATION OF LAW, WHICH ARE HEREBY EXPRESSLY DISCLAIMED. IN NO EVENT SHALL MANUFACTURER BE LIABLE TO PURCHASER OR THIRD PARTIES FOR SPECIAL, INCIDENTAL, CONSEQUENTIAL, PUNITIVE, EXEMPLARY OR OTHER SIMILAR DAMAGES.

Manufacturer does not warrant, guarantee or provide any remedy for, and this Limited 25 Year Product Warranty shall be void and of no effect regarding, damage(s) caused by: (i) improper storage or handling, improper installation and/or failure to follow Manufacturer's written installation guidelines in effect at the time of purchase, or changes to the structure after original installation, including, but not limited to movement or failure of the structure on which TRIMAX products are attached; (ii) acts of God, including without limitations, fire, flooding, hurricane, tornado, earthquake, or any other similar natural cause beyond the direct control of the Manufacturer; (iii) abuse, misuse or negligence; (iv) expansion and contraction; (v) color variations or changes; or (vi) transportation of TRIMAX products prior to use. In addition, Manufacturer will have no obligation to warrant TRIMAX products if Manufacturer has not received payment of the product claimed to be defective.

This Limited 25 Year Product Warranty may not be modified except in a written instrument signed by an officer of the Manufacturer. Manufacturer shall not be bound by, and Purchaser shall not rely upon, representations made by individuals or agents of Manufacturer (including without limitation authorized distributors of TRIMAX products) in regard to TRIMAX products, except as contained in this Limited 25 Year Product Warranty. This Limited 25 Year Product Warranty is only valid in the United States of America. This Limited 25 Year Product Warranty gives you specific legal rights, and you may also have other rights that vary from state to state. Some states' laws do not allow the limitation/exclusion of incidental or consequential charges, or otherwise restrict the limitations contained herein, so some of the exclusions above may not apply to you.

This Limited 25 Year Product Warranty is effective for all TRIMAX products sold on or after July 15, 2011.
